



Subject: Tender Award – 2023 Urban Roads Resurfacing (No. 102EN3004)

Report to: Thorold City Council

Recommendations

1. That Request for Tender NO. 102EN3004, respecting 2023 Urban Roads Resurfacing contract, **BE AWARDED** to Brennan Paving - Niagara, a division of Brennan Paving & Construction Ltd., at a contract price of \$114,708.00, including contingency and excluding HST;
2. That Staff **BE AUTHORIZED** to spend up to the full amount allocated for this project in the approved 2023 Capital budget subject to the parameters of the City's Purchasing Policy; and
3. That the Mayor and City Clerk **BE AUTHORIZED** to execute the necessary agreements/contracts.

Key Facts

- Council approved the Urban Resurfacing Program under the 2023 capital projects budget.
- Chapel St South (Clairmont to Portland) was identified by staff to complete the top lift of asphalt from the road project completed in a previous year.
- City Staff requested and received a tender with four (4) construction companies submitting their proposals.

Budgetary Status

Funding in the amount of \$180,000 was approved in the 2023 Capital Budget for this project.

Analysis

This year's Urban Roads Resurfacing Program includes Chapel St South (Appendix 1). The scope of work is comprised of top course asphalt, adjustment of appurtenances and required curb works that will result in the completion of the Chapel St South - Watermain Replacement and Road Reconstruction project completed in a previous year. Staff posted a Request for Tender in accordance with the city's Procurement Policy, closing on March 16th, 2023.

Four (4) firms submitted their proposals which were reviewed. The results are summarized as follows:

Rank	Contractor	Tender Price
1.	Brennan Paving - Niagara, a division of Brennan Paving & Construction Ltd	\$114,708.00
2.	Rankin Construction	\$114,925.00
3.	Steed and Evans Limited	\$132,500.00
4.	Circle P Paving Inc.	\$159,390.00

The submissions were reviewed for errors and omissions and staff can confirm that they are all qualified bidders.

Staff are recommending the tender award to Brennan Paving - Niagara, a division of Brennan Paving & Construction Ltd at a contract price of \$114,708.00, including contingency and excluding HST.

The estimated completion date for this project is September 2023.
