BY-LAW NO. XX-2024

A BY-LAW TO AMEND BY-LAW NO. 31-2023, BEING A BY-LAW TO ESTABLISH CERTAIN OFFICES FOR THE PURPOSES OF THE CORPORATION OF THE CITY OF THOROLD AND TO APPOINT PERSONS TO HOLD SUCH OFFICES.
