WHEREAS an LCBO store would contribute to the economic growth of the City of Thorold by providing employment opportunities and increasing foot traffic to local businesses; and

WHEREAS other municipalities of similar size and population have an LCBO store within their borders.

NOW THEREFORE BE IT RESOLVED THAT the Corporation of the City of Thorold enacts as follows:

- That the Mayor of the City of Thorold BE DIRECTED to write a letter to the Liquor Control Board of Ontario (LCBO) on behalf of Council to request that an LCBO store be brought back to the City of Thorold; and
- That the letter INCLUDE information respecting the population growth of the City of Thorold, the inconvenience faced by residents, and the economic benefits that an LCBO store would bring to the city.

WHEREAS City policy cannot override the Canadian Charter of Rights and Freedoms; and

WHEREAS the Charter is part of the Constitution of Canada, which is the Supreme Law of the Country.

NOW THEREFORE BE IT RESOLVED THAT the Corporation of the City of Thorold enacts as follows:

 That staff BE DIRECTED to amend the current code of conduct policy to reflect, adhere and recognize the Charter of Rights and Freedoms, as guaranteed under Constitutional law known as the supreme law of the land.

- That staff BE DIRECTED to obtain a legal opinion from an external legal counsel with constitutional law experience, other than the city's current Integrity Commissioner or their firm, on the City's Code of Conduct and whether it reflects, adheres to and recognizes the Charter of Rights and Freedoms, as guaranteed under the Constitutional law in Canada; and
- That the Motion BE DEFERRED until Council receives the legal opinion.
