**Subject:** Tender Award (102EN40010) – 2024 Traffic Calming for Multiple Locations  
**Report to:** Thorold City Council

---

## Recommendations

1. That Request for Tender NO. 102EN40010, respecting the 2024 Traffic Calming (Multiple Locations Citywide), **BE AWARDED** to Brennan Paving & Construction Ltd. at a contract price of \$67,767 excluding HST; and
2. That a budget reallocation of \$68,959.70 from the Pine/Sullivan Intersection Road Bump Outs budget **BE APPROVED** to fund the 2024 Traffic Calming Project, including speed humps at the identified locations within the City; and
3. That the Mayor and City Clerk **BE AUTHORIZED** to execute the necessary agreements/contracts.

## Key Facts

- Staff identified ten (10) locations within the City requiring speed humps and four (4) locations for the installation of other traffic calming measures within the City.
- The installation of traffic calming measures at the identified locations are required to reduce speeding and improve safety on the neighborhood roads.
- This report seeks Council's approval to authorize the reallocation of the \$68,959.70 remaining from the Pine/Sullivan Intersection Road Bump Outs to fund the installation of traffic calming measures at the identified locations within the City.
- The work is consistent with the intent and recommendations of the City's Strategic Plan.

## Budgetary Status

To fund the proposed traffic calming measures, a reallocation of \$68,959.70 from the 2024 Capital Project Pine/Sullivan Curb Bump Out project is required.

## Analysis

Council approved a series of traffic solutions for areas of traffic calming concerns. The approved solutions identified locations for the installation speed humps as shown in appendix A.

To install these speed humps Staff requested and received tender summarized as follows:

<b>Name</b>	<b>Estimated Price (Excluding HST.)</b>
Brennan Paving & Construction Ltd.	\$67,767
Circle P Paving Inc.	\$99,500

Staff are recommending the request for tender be awarded to Brennan Paving & Construction Ltd. at a contract price of \$67,767, excluding HST.

If awarded, the contract will commence on November 18, 2024, with an expected completion of December 13, 2024.

### **Impact on the Environment, Climate Change**

The City uses recycled materials where available.

### **Alternatives Reviewed**

1. Award the Contract – as bid and to the successful bidder.
2. Not Award the Contract – will not address the identified traffic related concerns.
3. Defer to next years capital budget – will prolong the implementation of the traffic calming measures at the identified locations.
