8. Roundtable Discussion

- T. Schilstra advised regarding accessibility concerns at the crosswalk at Pine Street South and Sullivan Avenue. Councillor D'Angela provided more information about the crosswalk and that this crosswalk has been a topic for the Road Safety Advisory Committee. Councillor O'Hare recommended this topic appear on a future Committee agenda.
- T. Schilstra enquired regarding the Thorold state of emergency regarding homelessness. Councillor O'Hare advised that the Niagara Region is looking at the issue and the City is supporting the Region. Councillor D'Angela advised that the City encourages developers to include affordable housing in new builds.
- J. Desroches enquired if the Committee can assist with the food scarcity issue in the community. H. McLean recommended inviting Community Care Thorold to present at a future meeting regarding this topic. Councillor D'Angela advised regarding food giveaways from a local anonymous donor and the work that was done with Community Care Thorold. The Committee discussed demographics of Thorold and that culturally appropriate food should be considered.
