

The Corporation of the City of Thorold

By-law No. 48-2021

A by-law to establish certain offices for the purposes of The Corporation of the City of Thorold and to appoint persons to hold such offices

Whereas Section 3(2) of the *Building Code Act, 1992*, S.O. 1992, Chap. 23, provides that the Council of each municipality shall appoint a Chief Building Official and such Inspectors as are necessary for the enforcement of this Act in the areas in which the municipality has jurisdiction; and

Whereas Section 229 of the *Municipal Act, 2001*, S.O. 2001, c. 25, provides that the Council of a municipality may appoint a Chief Administrative Officer; and

Whereas Section 228(1) of the *Municipal Act, 2001*, S.O. 2001, c. 25, provides that the Council of every municipality shall appoint a Clerk; and

Whereas Section 228(2) of the *Municipal Act, 2001*, S.O. 2001, c. 25, provides that the Council of a municipality may appoint Deputy Clerks who shall have all the powers and duties of the Clerk under this and every other Act; and

Whereas Section 286(1) of the *Municipal Act, 2001*, S.O. 2001, c. 25, provides that the Council of every municipality shall appoint a Treasurer; and

Whereas Section 286(2) of the *Municipal Act, 2001*, S.O. 2001, c. 25, provides that the Council of a municipality may appoint Deputy Treasurers who shall have all the powers and duties of the Treasurer under this and any other Act; and

Whereas Section 473(1) of the *Municipal Act, 2001*, S.O. 2001, c. 25, provides that a reference to a Tax Collector shall be deemed to be a reference to the Treasurer of the municipality; and

Whereas to Section 286(5) of the *Municipal Act, 2001*, S.O. 2001, c. 25, provides that the municipality may delegate to any person all or any of the powers of the Treasurer under this or any other Act with respect to the collection of taxes; and

Whereas Section 6(1) of the *Fire Protection and Prevention Act, 1997*, S.O. 1997, Chap. 4, provides that the Council of the municipality shall appoint a Fire Chief for the Fire Department; and

Whereas the Council deems it desirable to establish certain offices within the various departments of the Corporation and appoint the person to fill the offices so established.

Now therefore, the Council of The Corporation of the City of Thorold enacts as follows:

1. That the offices for the Corporation set forth in Schedule "A" to this bylaw under the Heading Title of Office are hereby established and confirmed.
2. That the offices established under Section 1 shall be held respectively by the persons whose names are set forth opposite said offices in the Schedule under the heading Name of Appointee.
3. That the said offices and their respective appointments thereto shall be deemed to be established and confirmed as of the respective dates set opposite thereto in the Schedule under the heading Effective Date of Appointment.
4. That the duties of the various offices set forth in the Schedule and the remuneration of the appointees thereto shall be as the Council may from time to time determine.

5. That the Manager of Building Services assumes the role of Deputy Chief Building Official for the sole purpose of enforcing the *Building Code Act* and the *Ontario Building Code* (ie. authorization of permits and orders) in consultation with the Director of Development and Engineering Services in the event that the Chief Building Official is absent.
6. That By-law 25-2021 is hereby repealed.

Read a first, second and third time and finally passed by Council this 20th day of April, 2021.
